# **HyperSlit**

#### 1. Product Overview

HyperSlit is an ultralight (380g) hyperspectral sensor system designed for precise spectral data acquisition across the UV (210–600 nm), Visible (350–800 nm), and NIR (650–1100 nm) spectra. It integrates seamlessly with platforms like drones, ground robots, and tripods, offering versatility in various applications.

## 2. Pricing and Payment Terms

- Price: Depends on the model and complexity.
- Payment Terms: 50% upfront upon purchase order confirmation; 50% upon delivery or within 14 days net (whichever comes first)
- Currency: EUR
- Payment Method: Bank transfer or other agreed methods

#### 3. Delivery Terms

## 9. Return Policy

- Return Period: Must be initiated within 30 days of delivery
- Process: Subject to evaluation and Return Merchandise Authorization (RMA) process
